CONTRACT TERMS & REGULATIONS

1. SERVICE AUTHORIZATION

Owner authorizes Mindful Mariners LLC ("Mindful Mariners") and its employees, contractors, and authorized agents to perform only the services selected, initialed, or otherwise expressly authorized on this Work Order. "Winterization" does not mean every component aboard the vessel will be inspected, diagnosed, serviced, drained, protected, or winterized. Owner is responsible for accurately identifying every system requiring service, including engines, generators, freshwater systems, water heaters, heads, holding tanks, air-conditioning, raw-water systems, washdown pumps, livewells, baitwells, ice makers, refrigeration, showers, sinks, pumps, seacocks, strainers, ballast systems, and other water-containing equipment.

2. PAYMENT & SCHEDULING

All fall/winterization Work Orders must be submitted and paid in full by October 1, 2026 unless otherwise agreed in writing. Services must be scheduled in advance. Submission does not guarantee a particular service date unless confirmed by Mindful Mariners. Failure to pay may result in cancellation or forfeiture of the service reservation. Except where otherwise required by law, payments are non-refundable once scheduling, materials procurement, mobilization, or work has begun. Returned checks/rejected payments may be assessed a \$50 fee to the extent permitted by law. Additional authorized labor, materials, access costs, marina charges, or services may be separately invoiced.

3. SHRINK-WRAP WARRANTY & WEATHER

Shrink-wrap workmanship is warranted for the winter season subject to Owner inspection and notice of any apparent workmanship issue within seven (7) days after completion. This is not a guarantee against all weather or storage conditions. Damage or failure caused by winds exceeding approximately 35 MPH, storms, heavy snow, ice, falling debris, animals, vandalism, marina activity, movement of the vessel/stands, third parties, or other conditions beyond Mindful Mariners' reasonable control is excluded and any repair/replacement is at Owner's expense. Mindful Mariners does not continuously monitor wrapped vessels unless separately contracted.

4. MOISTURE, CONDENSATION & MOLD

OWNER ACKNOWLEDGES THAT SHRINK WRAPPING CREATES AN ENCLOSED ENVIRONMENT AND MOISTURE, HUMIDITY AND CONDENSATION MAY OCCUR EVEN WHEN PROPERLY INSTALLED AND VENTILATED. TO THE FULLEST EXTENT PERMITTED BY LAW, MINDFUL MARINERS IS NOT RESPONSIBLE FOR MOLD, MILDEW, CORROSION, STAINING, ODOR, MOISTURE OR CONDENSATION DAMAGE, INCLUDING MOISTURE TRAPPED BETWEEN THE HULL AND WRAP OR WITHIN THE VESSEL. Additional padding/noodles, ventilation, or moisture-control products may be purchased when offered.

5. OWNER PREPARATION & EQUIPMENT

Owner must remove or properly secure loose, fragile, valuable, protruding, aged, or sensitive equipment before service, including canvas, enclosures, stanchions, antennas, radar domes, outriggers, electronics, flags, cushions, covers, personal property and loose gear. Unless Mindful Mariners expressly agrees to remove or protect an item, Owner assumes risks inherent in leaving it aboard. To the fullest extent permitted by law, Mindful Mariners is not responsible for damage to such equipment arising from conditions inherent in or incidental to the authorized shrink-wrap service.

6. WINTERIZATION LIMITATIONS

Systems may retain water due to vessel design, improper installation, blocked or deteriorated plumbing, inaccessible low points, failed pumps/valves, closed or malfunctioning seacocks, clogged strainers, disconnected hoses, defective equipment, manufacturer-specific procedures, pre-existing damage, or conditions not reasonably observable during ordinary service. Mindful Mariners is responsible only for the specifically authorized services performed using commercially reasonable marine-service practices.

7. OWNER DISCLOSURES / OMITTED SYSTEMS

Owner must disclose all equipment, modifications, unusual plumbing, hidden systems, known defects, manufacturer-specific procedures, and prior winterization problems reasonably necessary to perform the requested work. Mindful Mariners is not responsible for any system that was not disclosed, identified, accessible, or specifically included in the authorized Work Order.

8. PRE-EXISTING CONDITIONS

Mindful Mariners is not responsible for pre-existing damage, deterioration, corrosion, dry rot, brittle plastics, weakened hoses, aged wiring, deteriorated seals, failing pumps, damaged fittings, loose hardware, structural weakness, prior freeze damage, manufacturer defects, improper installation, or other conditions existing before service. Normal manipulation of aged marine equipment may reveal or cause an already weakened component to fail; such failure does not by itself establish that Mindful Mariners caused the underlying condition.

9. WEATHER, STORAGE & EVENTS BEYOND CONTROL

To the fullest extent permitted by law, Mindful Mariners is not responsible for loss or damage resulting from severe weather, flooding, high water, snow/ice accumulation, wind, fire not caused by Mindful Mariners, falling objects, animals, pests, vandalism, theft, acts/omissions of marinas or storage facilities, utility failures, movement or failure of blocking/stands not installed by Mindful Mariners, acts of third parties, or other events outside its reasonable control. Owner remains responsible for maintaining appropriate vessel insurance.



CONTRACT TERMS & REGULATIONS

10. POST-SERVICE ALTERATIONS

After winterization or shrink wrapping, Owner shall not operate, energize, fill, reconnect, alter, open, remove, or disturb a winterized system or wrap without understanding that doing so may compromise the service. Mindful Mariners assumes no responsibility for damage after its work has been altered, used, opened, disturbed, modified, or accessed by Owner or any third party.

11. ACCESS, KEYS, PUMP-OUT & BATTERIES

Owner shall provide timely access, keys, combinations, marina authorization, and other information required to perform the work. Vessels requiring pump-out must be pumped out before haul-out/winterization unless otherwise arranged. Failure may result in a \$75 fee plus third-party charges. A \$30 dead-battery service fee may be assessed when a dead/insufficient battery interferes with haul-out, testing, access, or service; additional charging, replacement, towing, marina, or equipment costs may also apply.

12. VESSEL DIMENSIONS

Shrink-wrap pricing is based on actual Length Overall (LOA), including bow pulpits, swim platforms, extensions, and other structures included within the wrapped footprint. If actual dimensions exceed those represented by Owner, Mindful Mariners may adjust the invoice and Owner agrees to pay the resulting balance.

13. DETERIORATED OR UNSAFE WRAP

If shrink wrap deteriorates, becomes unsafe, creates a hazard, threatens the vessel/surrounding property, or no longer reasonably provides intended protection, Mindful Mariners may remove some or all of it when reasonably necessary. Where practicable, Owner will be contacted first. Emergency conditions may require action without prior authorization. Removal, disposal, repair, or replacement not attributable to defective initial workmanship may be charged to Owner.

14. ASSUMPTION OF RISK & LIMITATION OF LIABILITY

OWNER ACKNOWLEDGES THAT BOAT WINTERIZATION, HAUL-OUT SUPPORT, SHRINK-WRAP INSTALLATION, OUTDOOR STORAGE AND MARINE SERVICE INVOLVE INHERENT RISKS THAT CANNOT BE COMPLETELY ELIMINATED. TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, OWNER ASSUMES THE RISKS INHERENT IN THE AUTHORIZED SERVICES AND RELEASES MINDFUL MARINERS LLC, ITS MEMBERS, EMPLOYEES, CONTRACTORS AND AGENTS FROM CLAIMS FOR LOSS OR DAMAGE ARISING FROM THOSE INHERENT RISKS, PRE-EXISTING CONDITIONS, OWNER'S FAILURE TO DISCLOSE VESSEL SYSTEMS OR CONDITIONS, WEATHER/ENVIRONMENTAL CONDITIONS, THIRD-PARTY ACTS, OR OTHER EXCLUDED CONDITIONS DESCRIBED HERE. Nothing in this Agreement excludes liability that cannot lawfully be excluded.

15. CONSEQUENTIAL DAMAGES / LIABILITY CAP

TO THE FULLEST EXTENT PERMITTED BY LAW, MINDFUL MARINERS SHALL NOT BE LIABLE FOR INDIRECT, INCIDENTAL, SPECIAL, EXEMPLARY, PUNITIVE, LOSS-OF-USE, LOSS-OF-INCOME, LOSS-OF-CHARTER-REVENUE, DIMINUTION-IN-VALUE, OR CONSEQUENTIAL DAMAGES. To the extent permitted by law, any liability arising directly from an authorized service is limited to the amount paid to Mindful Mariners for the specific service giving rise to the claim, except where a different limitation is required by law.

16. INSPECTION & NOTICE OF CLAIM

Owner agrees to inspect the vessel and completed work within a reasonable period after service and again before recommissioning. Any alleged problem should be reported promptly and, when reasonably possible, before another person repairs, alters, removes, or disposes of the affected work/component so Mindful Mariners has a reasonable opportunity to inspect. Failure to provide a reasonable inspection opportunity may impair Mindful Mariners' ability to evaluate responsibility.

17. UNPAID BALANCES / LIEN RIGHTS

Owner remains responsible for all authorized charges, materials, taxes, marina charges, and other amounts properly due. Mindful Mariners reserves all rights and remedies available under applicable state and federal law concerning unpaid vessel-related charges, including any lien rights that may lawfully arise. This Agreement does not automatically create a maritime lien where applicable law does not provide one.

18. ENTIRE AGREEMENT / SEVERABILITY

This Work Order, together with incorporated written estimates, invoices, and service selections, constitutes the agreement concerning the authorized services. If any provision is held invalid or unenforceable, the remaining provisions remain effective to the fullest extent permitted by law. No oral statement modifies these terms unless confirmed in writing by Mindful Mariners.
